




## The Clash of Globalizations: **The Structure.**


- Multiple processes of qualitative change.
- Clash of Globalizations as a metaphor for the several processes of major structural transformations in the world.
- World changes not seeing in a century: causation and the processes emerging from the Chinese Embedded Globalization.
- Towards an embryonic globalization.



### The Clash of Globalizations: The Pillars.

- The embryonic changes in the neoliberal paradigm occur by an interloop between the transformation of the world market and the foundation of new institutional arrangements.
- These institutional arrangements appear in many forms: from diffuse legal entanglements (such as the BRI) to minilateral and multilateral forums for discussion (such as FOCAC, CELAC, the CIS, COSBAN) to institutional initiatives (as the New Development Bank).

### The Formation of the BRICS plus.


- The BRICS emerge as a political formation arising from systemic chaos.
- A new distribution of global power reordering.
- A contemporary multicenter system.
- Financial cooperation arrangements: The most important institutional achievement of the BRICS group.



## The Formation of the BRICS plus.


We can trace four distinctive moments of qualitative change towards institutional evolution.

- 2009 The first moment of evolution happened during the crisis of neoliberal globalization. The crisis catalyzed previous negotiations over the creation of an emerging countries organization, evolving from previous arrangements to a more formal and effective international affairs coordination.
- 2014 The formation of the BRICS Bank now the NDB and the Contingent Reserve Arrangement established the framework for the provision of liquidity in response to potential short-term Balance of Payments pressures.
- 2018 The cooling down of the intraBRICS relations, with the members acting in a less coordinated ways, promoting bilateralization. This coincided with the emergence of the USChina rivalry at the global stage.
- 2022 The announcement of the desire to extend the cooperation initiative to other emerging and developing markets at the Xiamen Summit.



### Towards a Contemporary Understanding of the BRICS plus.

- The idea of outreach.
- The process of establishing structures for the BRICS outreach dates back to the 2010 Brasilia Summit, where provisions for the invitations of non-member countries were stablished at the final documents of the forum.
- Throughout the 2010s decade, the evolving relationship of the BRICS enabled the expression of regional interests at the centerstage of the forum, enabling the discussion of expanding to interested regional partners the discussion of core objectives for the host nations.






#### Agenda Formation

- China pointed to ASEAN+1 and the African Union.
- Russia focused on the Commonwealth of Independent States
- India aimed at regional South Asian Partners
- Brazil focused on UNASUR and MERCOSUR engagements
- South Africa furthered its vision for a intra-BRICS discussion of the New Partnership for Africa's Development and the South African Development Community.

### BRICS plus... Who?

- Conflicts of Interest can arise from interregional arrangements regarding the expansion of the BRICS as a formal bloc.
- Global issues and regional engagements can superpose previous cooperation initiatives.
- Nonetheless, at the 2023 Johannesburg Summit, the consolidation of the (first?) great expansion of the BRICS plus happened with the formal invitation of Argentina, Egypt, Ethiopia, Iran, the UAE and Saudi Arabia.
- The possibility for decline: the Case of Argentina.



#### Concluding remarks.

The **strategy of outreach** may transform the BRICS plus to a condition of minilateral political formation into an organization aimed at complex multilateralization.

The domino effect of expansion: over 40 interested potential members have already verbalized their interests in joining BRICS plus formal institutions.

The **future of the organization** may lead scenario of **integration of integrations**, in which a hybrid form of expanding (or not) of the original core happens while new members join the organization.

The formal articulations of the geopolitical links between the state point to the formalization of integrated strategies, like the BRICS common currency, or ulterior Global South-focused geopolitical articulations.

These are all important signs of the qualitative transformations, and point to further developments of the interaction between socio-economic formations within the global capitalism.
